# **CARINE SHS UNIFORM POLICY 2023**



## All students must:

- ensure the uniform is clean, tidy, not ripped and free of graffiti
- ensure the midriff is covered at all times
- not wear clothing that exhibits any logo other than the school logo
- not wear head gear in class (including hats and beanies)
- not wear excessive makeup or jewelry including spiked or hooped facial piercings
- not wear miniskirts, stretch skirts, skirts with high splits, or close fitting mini shorts
- not wear leggings or tights as an outer garment
- only wear full length leggings or tights as an under garment
- not wear denim
- not wear any clothing that has advertising or inappropriate language or pictures
- have enclosed and practical shoes

## The school uniform for all is:

#### **Uniform General Wear:**

- casual shorts with school logo
- sport shorts with school logo
- sports track pant with school logo
- school dress with school logo
- school skirt with school logo
- polo top with school logo
- long sleeve polo top with logo
- button up shirts or blouses with school logo as an option for Senior School only
- bomber style jacket with school logo
- · leavers jacket or approved special event windcheaters
- plain black or navy stockings

#### **Sports and Physical Education Uniform:**

- navy blue sports shorts with red panels with school logo
- red sports polo top with navy blue panels with school logo
- navy blue track pants with red panels with school logo
- sports shoes and socks
- Carine SHS bathers or own bathers

These items are not permitted to be worn under the school uniform. Students are only permitted to wear the PE uniform during PE and students must change into and out of this uniform at the commencement and conclusion of PE classes/activities.

## Dance Uniform:

- PE polo top
- PE shorts or track pants, plain black shorts, or plain black leggings

These items are not permitted to be worn under school uniform. Students are only permitted to wear the Dance uniform during Dance and students must change into and out of this uniform at the commencement and conclusion of Dance classes/activities.

#### Dress requirements in practical areas:

It is a legal requirement that students in practical areas of Home Economics, Science, Art and Design & Technology must:

- wear enclosed footwear
- wear safety glasses when required to do so
- have long hair tied back or covered securely
- wear approved protective clothing where applicable

Students failing to comply with these requirements may be withdrawn from practical classes.

#### Dress requirements for out of school activities:

- students attending official functions, as representatives of the school will be required to wear a school blazer, white button up shirt or blouse, school tie, long pants or skirt and black shoes
- students attending Work Experience/Workplace Learning will be advised of specific dress standards which conform to employer requirements and health and safety regulations
- students attending out of school excursions are required to wear school dress to be easily identifiable as a school group unless otherwise indicated

#### Non-compliance with School Dress requirements:

Any student who arrives at school in dress that does not meet the requirements will be directed to Student Services and appropriate action will be taken including changing into loan uniforms which must be returned laundered. Please see the Uniform Process Flow Chart 2023.
